- Students interested in transferring to Herzing University should submit transcripts to the Herzing Admissions Department from all post-secondary institutions previously attended for evaluation.
- Unofficial transcripts may be used for a preliminary evaluation, however credit will not be formally awarded until official transcripts are received.
- Credits are evaluated on a course-by-course basis and transfer credit will be awarded for comparable coursework.
- Students who attended a college or university that closed within the last 12 months (of their start date with Herzing University) and were attending within 120 days of the school closure date will be considered for the following exceptions to Herzing University's transfer credit policy:
 - Residency requirements will be waived for both undergraduate and graduate programs. Documentation of the exception will be included on the transfer credit evaluation form and be maintained in student's academic record. Students must successfully complete at least one program requirement at Herzing University in order to receive a credential.
 - Letter grades of "D" earned in coursework completed at the previous institution will be considered for credit in undergraduate programs for students who have a cumulative GPA of 2.0 or higher with the exception of clinical healthcare coursework and certain classes in clinical healthcare programs.
 - Letter grades of "C" earned in coursework completed at the previous institution will be considered for graduate transfer credit for students who have a cumulative GPA of 3.0 or higher with the exception of clinical healthcare coursework.

Describe your transfer admission requirements, review process and timeline, including incentives for Argosy students:

- The enrollment fee shall be waived for all students transferring from closed institutions.
- The Herzing University Entrance Testing requirements will be applied as described in the Undergraduate Admissions Criteria section of the catalog. Students who have successfully completed 24 semester credits of college-level work with a CGPA of 2.0 or higher for undergraduate programs will be exempt from taking the Entrance Exam. The college placement evaluation is required unless the applicant has completed a college-level English composition course and a college algebra course or higher with grades of "C" or higher.
- Prospective students interested in the **Bachelor of Science in Dental Hygiene (BSDH)** program will need to contact the Director of Admissions, Jennifer Sekula, for information regarding enrollment requirements and transfer of credit requirements. The above outlined requirements differ for the BSDH program. Entrance Testing will be required for admittance into the Dental Hygiene program.
- Transfer credit evaluations and Acceptance will be determined within 3 business days after completion of admission testing and receipt of all admissions documents.

Herzing University is committed to making transfer affordable to Argosy students.
